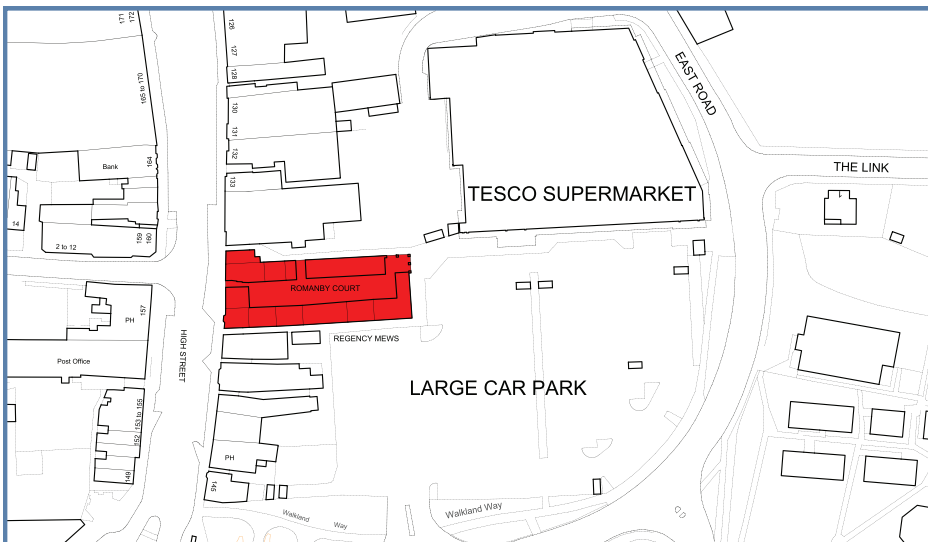

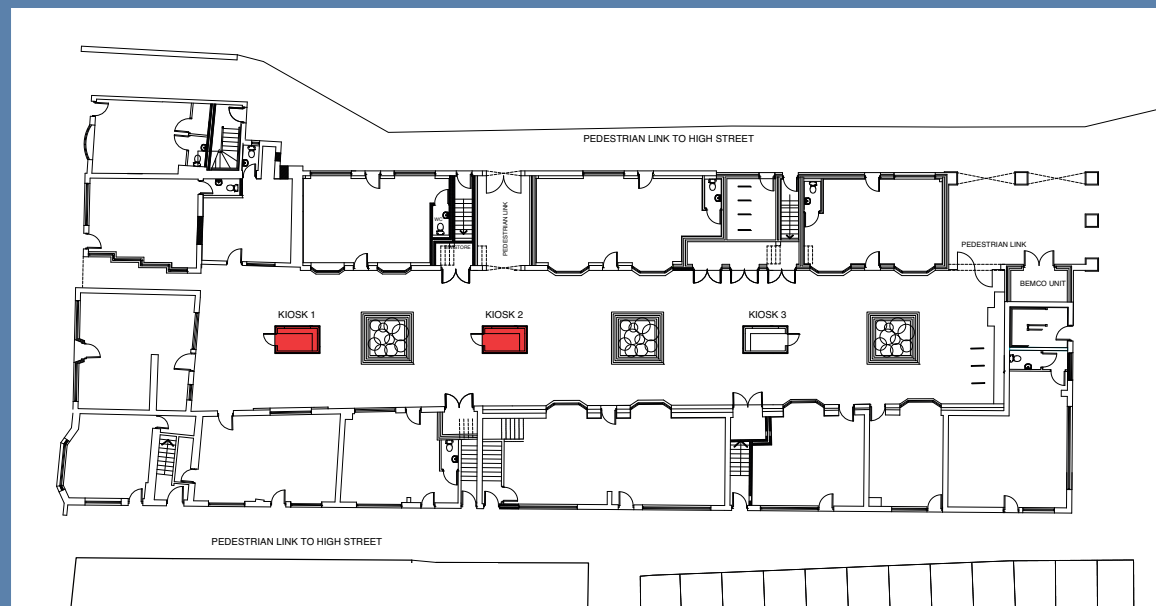
LOCATION
